Terms of Reference (ToR) for provision of health insurance services

1. Project Background

To guarantee access to suitable insurance coverage, AKF plans to conduct a thorough market assessment of insurance providers with objectives to:

- Comprehensively understand the market landscape and the insurance companies operating in Tajikistan.
- Gain insights into the range of services offered by each provider.

This initiative will enable AKF to form strategic partnerships with esteemed and dependable insurance company capable of delivering services that align with AKF's requirements.

Aga Khan Foundation (AKF) invites interested and eligible parties from specialized bidders or suppliers to prepare proposals for the provision of health insurance services. Service supplier shall be selected in accordance with competitive bidding procedures and the best overall value procurement results provided by AKF.

3. Qualifications and Requirements

- The bidder should be legally allowed to provide required services inside of the county.
- The bidder should have demonstrated experience in provision of insurance services (both locally and/or internationally).
- Financial stability indicated by the provider's capital.
- Information about stakeholders.
- Client base.
- Geographic reach of services.
- Comprehensive list of services, including inpatient, outpatient, hospitalization, emergency care.
- Availability of digital services.
- References and track record of past performance.
- Effective communication and customer service skills.

Additional requirements

- To observe the principle of ensuring environmental protection, as well as abandoning any negative impact on human life and environment.
- To be able to provide a Code of Conduct, anti-fraud, corruption/bribery policies, if required.
- To comply with donors' requirements regarding sanctions, if required.
- To be able to provide certificates from tax inspectorate on the absence of debt, if required.

• To be able to provide samples, detailed specifications/photographs, proofs of required materials/equipment and services.

4. Deliverables

- Collective health insurance (medical examination, outpatient treatment (consultation of the doctor as per medical indications, laboratory and diagnostic tests, instrumental and diagnostic methods of research, various diagnostic and therapeutic manipulations, carried out on the outpatient basis, medicines designated for outpatient treatment, examination and treatment by a dentist), impatient treatment (hospital treatment), emergency care).
- Collective insurance from accidents.

5. Timeline

The term of the contract for insurance services will be one year with the possibility of extension based on performance and mutual agreement.

6. Bidder proposal should include:

- 1. Letter of Interest, including names and contact information of three previous clients who can be contacted regarding relevant experience.
- 2. Detailed financial proposal clearly demonstrating a thorough understanding of this request for proposals, including the following:
 - The bidder's profile and experience in similar projects.
 - Cost breakdown for services provided with payment terms and conditions, stating the validity period of proposal/costs.
 - Proof of business registration and nationality (company registration, licenses/ permissions, tax registrations, etc.).
 - The proposal should be submitted in English and Tajik/or Russian.
