## I. General information

1. Brief information on the project

<u>Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH (German Development Cooperation).</u>

The Multi Donor project "BaSIC - Building a System on Integrated Primary Care in Tajikistan" is jointly funded by the European Union and the German Federal Ministry for Economic Cooperation and Development (BMZ). The Action is part of the EU Health Development Programme (EU HDP) in Tajikistan and is implemented by Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) GmbH.

The specific objective of the Action is to improve the quality of and access to integrated primary health care (PHC) services. The Action will strengthen the PHC system and lead to an improved quality of service delivery in 28 selected partner districts as well as improved access to PHC services for local communities by strengthening the organisational efficiency in PHC Centers, by improving the competencies of family doctors, nurses and midwives and administrative professionals as well as by restoring trust in and acceptance of family medicine in local communities.

The principal strategy of this Action is to support the Government of Tajikistan with implementing the Primary Health Care System Development Plan based on Principles of Family Medicine (2021-25).

The target group of the Action – the general population in the partner districts (app. 3.65 million people) – will be reached by capacitating 30 Level III PHC Centers (District/City Health Centers/ Poly Clinics) and all 461 Level II PHC Centers (Rural/ Village Health Centers) in the selected districts. Thereby, the Action targets directly 53 per cent of all Level II and Level III primary health care facilities in Tajikistan and improves framework conditions for the remainder of PHCs through engagement at the national level. In addition, the Action will reach out to the medical houses and medical points (Level I) in the selected districts, where feasible.

One of the objectives of the MHSPP of Tajikistan, specified in the "National Health Strategy of the Republic of Tajikistan for the period up to 2030", approved by the Resolution of the Government of the Republic of Tajikistan, is integration of vertical programmes into primary health care which already started in some pilot districts in 2011. In Tajikistan, many vertical programs (IMCI, Immunization, Reproductive Health) are now fully or partially integrated into primary health care structures. However, today HIV/AIDS and TB are still a high burden in the country.

Under the BASiC project, in the period 2022 - 2023, the process of integration of HIV services is carried out in PHC facilities, by training specialists of these facilities (family doctor and family nurse) and equipping their offices in 10 pilot districts of Vose (3 HIV sites), Bobochon Gafurov (3 HIV sites), Tursunzoda (3 HIV sites), Ishkoshim (3 HIV sites), Khorog (2 HIV sites), Rushon (3 HIV sites), Panj (3 HIV sites), Vahdat (3 HIV sites), Panjakent (3 HIV sites), 6. Istaravshan (3 HIV sites).

In early 2024, the HIV integration process is expanded to another 10 pilot districts - 29 newly established HIV sites:

- 1. Shahrinav district (3 HIV sites).
- 2. Kulob (Jargala) district (3 HIV sites).
- 3. Muminobod district (3 HIV sites).
- 4. Temurmalik district (3 HIV sites).
- 5. Norak district (3 HIV sites).
- 6. Bokhtar city (2 HIV sites).
- 7. Darvoz district (3 HIV sites).
- 8. Vanj district (3 HIV sites).
- 9. Shugnon district (3 HIV sites).
- 10. Roshtqala district (3 HIV sites).

#### 2. Context

The main objective of the proposed Terms of Reference (ToR) is collection, sorting, delivering and installation of IT, technical and medical equipment for HIV services integration to 29 HIV sites (PHC facilities) in 10 (ten) pilot districts in 3 regions of Tajikistan (RRS 1 district, 5 districts in Khatlon region and 4 districts in GBAO. Anex with Itemes and districts of distribution is attached to the current TOR. Safe delivery to destination and insure that all below mentioned Itemes delivered to appropriate points.

3. GIZ shall hire the contractor for the anticipated contract term, from 25 November 2024 to 30 April 2025.

The services described in Section 4 shall be provided until end of February 2025

- 4. The contractor shall provide the following work/service:
  - 1. Transport of HIV and TB commodities along the following routes (as per attached distribution table):
    - a. **Dushanbe Shahrinav District:** A. Hasanov Rural Health Centre (RHC) of Shahrinav District "Tojikiston" Rural Health Centre (RHC) of Shahrinav District; "Chust" Rural Health Centre (RHC) of Shahrinav District;
    - b. **Dushanbe Kulob (Jarqala) district:** "Hokimobod" Rural Health Centre (RHC) Kulob district, "Chorbog" Rural Health Centre (RHC), "Hatlon" Rural Health Centre (RHC) of Kulob district;



- c. **Dushanbe Muminobod district:** "District Health Centre (DHC) of Muminobod district "Shamsiddin Shokhin" Rural Health Centre (RHC), "Bogi Habib" Rural Health Centre (RHC) of Muminobod district;
- d. **Dushanbe Temurmalik district:** "District Health Centre (DHC) of Temurmalik district, "Tanobchii Bolo" Rural Health Centre (RHC), "Kangurt" Rural Health Centre (RHC).
- e. **Dushanbe Norak city:** "District Health Centre (DHC) of Norak district, "Dukoni " Rural Health Centre (RHC) of Norak district, "Tutkaul" Rural Health Centre (RHC) of Norak district;
- f. **Dushanbe Bokhtar city:** Bokhtar City Health Centre (CHC), " Balkhi 1" (J. Rumi) Rural Health Centre (RHC);
- g. **Dushanbe Darvoz district:** District Health Centre (DHC) of Darvoz district, "Sagirdasht" Rural Health Centre (RHC), "Chorf" Rural Health Centre (RHC);
- h. **Dushanbe Vanj district :** " District Health Centre (DHC) of Vanj district, "Vahdat" Rural Health Centre (RHC) Vanj district, "Garmchashma" Rural Health Centre (RHC), Vanj district;
- i. Dushanbe Shugnon district: District Health Centre (DHC) of Shugnon district, "Porschnev" Rural Health Centre (RHC), "Buni" Rural Health Centre (RHC), Shugnon district;
- j. Dushanbe Roshtkala District: "District Health Centre (DHC) of Roshtqala district ""Tavdem"" Rural Health Centre (RHC) Roshtkala District """Sejd"" Rural Health Centre (RHC), Rohtkala District ".
- 2. Contractor shall collect, sort commodities according to the enclosed distribution table
- 3. Contractor shall load and unload at the locations specified in the HIV sites distribution list provided by GIZ
- 4. The contractor shall deliver the HIV commodities to the destination as agreed and within the timeframe agreed with the GIZ.
- 5. Delivery and handover of HIV Goods shall be done according to the distribution list provided by GIZ.
- 6. Inform the GIZ in advance if the goods are ready for dispatch (shipment)
- 7. Ensure checking the condition (operability) of supplied HIV commodities when loading from storage and further during transfer of commodities to the place of destination
- 8. insure (cover risk and cost of transport) until the goods are delivered to the place stated in the delivery terms and within the period agreed with the GIZ
- 9. deliver the goods precisely in accordance with the list and quantity of tools specified in the accompanying documents of the GIZ.
- 10. install the furniture and set up the set in the designated rooms of the responsible family doctors and take pictures.
- 11. Contractor is obliged to hand over the documents (data sheet, quality certificate, user manual, etc.) and the available accessories at the same time as the tool is handed over to the recipient.
- 12. If the quantity handed over does not correspond with the quantity stated in the delivery documents, inform the GIZ representative.
- 13. apply the GIZ logo to the commodities
- 14. submit the handover documents (delivery notes) of the goods to the GIZ on time
- 15. submit photos and delivery report of each HIV site.
